- 17/01979/FUL 12 Hoe Lane Rettendon Common Replace existing conservatory roof with a replica tiled roof. Comment: This a Rettendon application close to the border with Runwell. No objections.
- 2. 17/01976/FUL Orama 2A Lindon Road First floor extension, conversion of garage to habitable space with new canopy over. Comment: No objections
- 3. 17/01893/FUL 14 David Avenue Proposed loft conversion with flat roof dormer to front elevation. Single-storey rear extension. Comment: The rear extension is not mentioned on the application form but included on the plans submitted. No objection.
- 4. 17/01731/FUL Runwell Community Primary School Retrospective application for a timber eco building. (Amended application position of building moved) Comment: RPC state this should be a completely new application; the position of the building is completely different to the first application and is no longer a retrospective application as the building is yet to be sited. Strong letter of objection received from the Mrs Hall 25 Clare Avenue. Car parking provision for staff not shown. No dimensions shown on the drawing as to the exact positioning of the building and appears to be close to the boundary with 25 Clare Avenue, it should also show a fenced area which will be needed for the protection of the children.

- 6. 16/00684/MAT/2 Phase 3B Runwell Hospital Site Runwell Chase Material amendment to permission reference 16/00684/FUL (Conversion of, and extensions to, former Administrative Building to accommodate 14no. residential apartments with associated access, parking and landscape arrangements.) in order to raise the approved floor levels of the northern duplex units. Comment: Part of the original permission stated that no building would be higher than the original building, the design should reflect this.
