Minute 12 Planning

1. Applications Received:

- (i) 17/00675/FUL 27 Lindon Road First floor rear extension with new first floor side window. No objection subject to window being obscure.
- (ii) 17/00729/FUL 6 South Hanningfield Way Single storey front/side extension. Single storey garage to side. Raising of the roof, hip to gable extension and side facing dormer window. No objection.

The Chairman reported on his attendance of the recent Parish Council Forum at Chelmsford City Council on Planning. One of the planning officers had offered to visit the parish council to give some training on day to day planning matters. It was agreed to take up this offer and set a date for the training.

2. St. Luke's Development

The Chairman invited RR to report. RR advised the Parish Council of a joint meeting with Countryside, HCA, senior staff of CCC Planning and the City Council representatives on 19th April. Safety audit to be completed on the attenuation ponds. Sarah Coleman to pass on reports to residents. St. Luke's Chapel was discussed but there is no clear timescale for the renovation. It is still Countryside's intention to sell on the building as a potential business to recoup the costs. The Parish Council maintains its concern that the building will be sold on as a "Nursery" rather than a Community Facility or "Hub" as indicated in the planning consent. RR further reported on affordable housing, shared equity properties and units for rent. The site thefts are of concern, RPC to write to Police Commissioner. MM/JS/CE reported further issues re landscaping – dying trees; problems with ditches; timing of the provision of the new school. The new St. Mary's Crossing will be going ahead.

3. Land opposite Toby Carvery – Planning Enforcement Issues See Minute 11 (i) The Enforcement team have their own drone and are fully aware of all the issues taking place behind the straw bale wall. Action is being taken.

Minute 13 Meadow Lane

See Minute 11 (ii). There has been a report that raw sewerage is getting into Runwell Brook. RPC to report matter to CCC Public Health and Protection to test the water.

CE reported that she had virtually completed the project with just a couple of areas still to review. Work to be forwarded to ECC in due course. The Chairman thanked CE for all her hard work in completing this project for use by ECC.
