Minute 136 Budget Items for Precept 2019/20

Carry over last year's budget items with additions as follows:

- Play Equipment to upgrade facilities by £25k in addition to existing reserve from S106/CIL monies

- Upgrade CCTV system from analogue to digital £7500 (inc Maintenance contract)
- Electrical Upgrade to achieve compliance £3k

Minute 137 Overflow Car Park
